Safeguarding Message – Mobile phones

Mae wedi dod i'r amlwg wythnos yma bod mwy a mwy o ddisgyblion yn dod a ffôn symudol i'r ysgol. Gofynnwn felly i chi fel sicrhau nad yw eich plentyn yn dod a ffon mewn i'r ysgol os nad oes rheswm pendol a'i fod yn fater o ddiogelwch personol. Os yw cario ffon yn rhywbeth dyddiol/wythnosol a allwch chi ddanfon llythyr mewn i'r Ysgol yn nodi pryd a pam.

Gofynnwn i chi hefyd atgoffa eich plentyn os oes ganddynt ffon rhaid troi y ffon i ffwrdd a rhoi y ffon yna o dan ofal yr athrawes ddsbarth yn ystod y dydd.

Hoffwn hefyd eich atgoffa o'r canllawiau oedran o ran y cyfryngau cymdeithasol amrywiol.



Noder mae'r canllawiau oedran mewn lle oherwydd cyferithiau diogelu data. Does dim hawl gan wasanaethau arelin gasglu na storio gwybodaeth bersonol plant os ydynt o dan 13 oed. Mae cyferithiau date hefyd yn nodi mai DIM OND plant dros 13 oed sydd yn medru arwyddo i fyny i wasanaethau ar lein heb ganiatad rhieni.

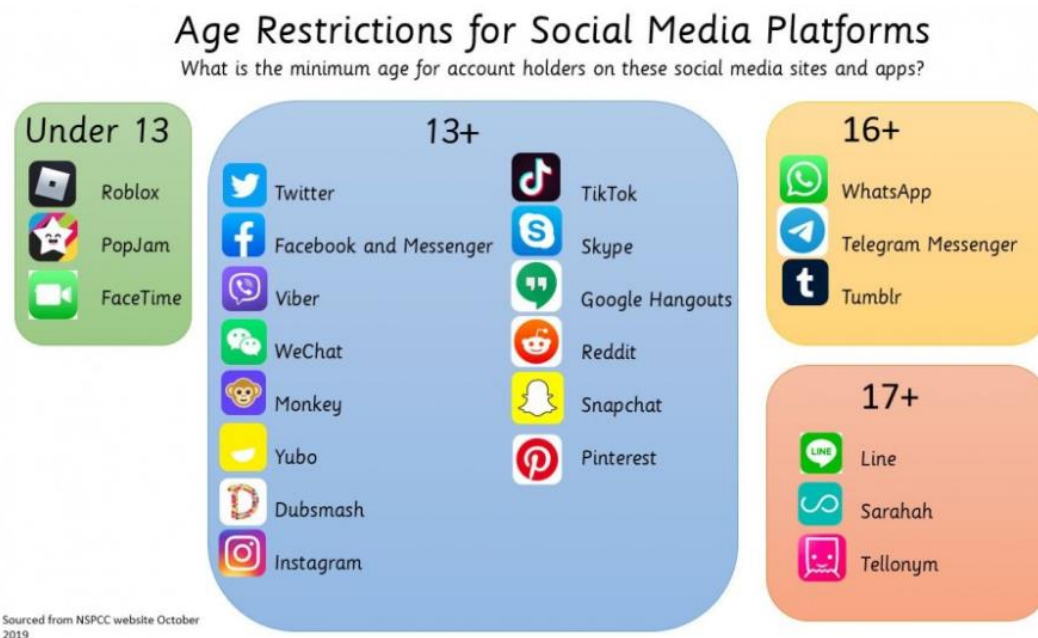
Diolch am eich cydweithrediad yn y mater hwn

It has come to our attention that more and more pupils are bringing a mobile phone to school. Some older pupils have always brought a phone if they are walking home or walking to hockey sessions from school and we fully understand this is important to ensure personal safety.

We kindly ask you to ensure that your child DOES Not bring a phone into school if it is not necessary and that it is a matter of personal safety. If carrying a phone is a daily / weekly need then please send in a letter to the class teacher noting when and why they need a phone in school.

Please also remind your child, if they have a phone in school to make sure it's turned off and handed in to the class teacher who will keep the phone during the school day.

We'd also like to remind you of the age guidance for different social media apps / services:



Please note that the age requirements are there because of data protection laws. Online services are not allowed to collect or store children's personal information if they are under the age of 13. Data protection laws also say that only children aged 13 and over can sign up to online services without parental permission.
