*Schools are expected to make the best use of this funding to implement sustainable strategies that will quickly bring about changes for learners eligible or who are CLA.*

*This statement details our Federation's use of the PDG for the 2025 to 2026 academic year. It outlines our strategy, how we intend to spend the funding in this academic year.*

#### **Statement of Intent**

As a Federation we have agreed the following three steps:

1. To identify the target group of pupils, its characteristics and needs
2. To plan interventions which make the most effective use of resources
3. To monitor and evaluate the impact of resources
4. To subsidise residential visits for pupils ( Year 4-6)

Within the Federation we have a comprehensive plan, agreed and monitored by Carmarthenshire Local Authority to promote progress and remove barriers to learning for students eligible for this funding.

We have used the funding available to:

- Employ staff that can provide intervention and support programmes that will ensure strong progress for these pupils.
- Provide intervention and support programmes that are proven to have the greatest impact and to be sustainable – Chatt, Elsa, Blociau Bendigedig, positive play.
- Provide intervention within basic literacy & numeracy skills with RWI, tric a chlic, phonological awareness.

Our detailed plan which includes details in respect to how we're spending the grant and the effect of the grant is available within the schools.
